The Board, by unanimous vote, without abstentions, adopted an initial resolution (resolution 16-154) to issue up to \$20,000,000 in multi-family housing revenue bonds for Miller Avenue Senior Housing, LP (Rotary Miller Avenue Senior Housing) City of South San Francisco, County of San Mateo.

Motion by McCarthy; Seconded by Adams; Motion carries.

The Board, by unanimous vote, without abstentions, adopted an initial resolution (resolution 16-155) to issue up to \$45,000,000 in multi-family housing revenue bonds for Beacon Pointe L.P. (Beacon Pointe Senior Homes/Beacon Place Supportive Homes for Veterans Apartments), City of Long Beach, County of Los Angeles. Motion by Westerlund; Seconded by Watanabe; Motion carries.
