Executive Director, Edward Becker attended. John Stoecker, Lee McCormick, and Ben Barker of Sierra Management Group L.L.C., attended as financial advisors to the Authority. Katrina Dair and Alexis Tudor of Sierra Management Group L.L.C., attended as Administrative Staff. Ron Lee, of Jones Hall, APLC, attended as counsel to the Authority.
