Executive Director, Edward Becker attended. John Stoecker, Lee McCormick, Ben Barker and Anthony Stubbs for Sierra Management Group L.L.C. attended as financial advisors to the Authority. Stephen Melikian of Jones Hall, APLC, attended as counsel to the Authority.

The minutes of the regular and special meetings of the Board on July 17, 2015 were discussed and approved. Motion by Adams; Seconded by Watanabe; Motion carries by unanimous vote, without abstentions.

There was no public comment.

The Executive Director reminded the Board that recommendations to the Board on agenda items were made on the respective staff reports provided and the Executive Director reiterated those recommendations.

The Board, by unanimous vote, without abstentions, adopted an initial resolution (resolution 15-085) to issue up to \$12,000,000 in multi-family housing revenue bonds for Rancho California, LP (Rancho California Apartments), City of Temecula, County of Riverside.
