The minutes of the regular meeting of the Board on June 12, 2015 were discussed and approved. Motion by Adams; Seconded by McCarthy; Motion carries by unanimous vote, without abstentions.

The Executive Director reminded the Board that recommendations to the Board on agenda items were made on the respective staff reports provided and the Executive Director reiterated those recommendations.

The Board, by unanimous vote, without abstentions, adopted an initial resolution (resolution 15-070) to issue up to \$10,000,000 in multi-family housing revenue bonds for Schillo Gardens, L.P. (Schillo Gardens Apartments), City of Thousand Oaks, County of Ventura.

The Board, by unanimous vote, without abstentions, adopted a final resolution (resolution 15-071) to issue up to \$47,000,000 in multi-family housing revenue bonds for American Gold Star Manor, L.P. (American Gold Star Manor Apartments), City of Long Beach, County of Los Angeles.
