Executive Director, Edward Becker attended. John Stoecker, Lee McCormick, Ben Barker and Anthony Stubbs for Sierra Management Group L.L.C. attended as financial advisors to the Authority. Ron Lee of Jones Hall, APLC, attended as counsel to the Authority.

The minutes of the regular and special meetings of the Board on September 18, 2015 were discussed and approved.

Motion by Connors; Seconded by Watanabe; Motion carries by unanimous vote, without abstentions.

There was no public comment.

The Executive Director reminded the Board that recommendations to the Board on agenda items were made on the respective staff reports provided and the Executive Director reiterated those recommendations.

The Board, by unanimous vote, without abstentions, adopted an initial resolution (resolution 15-116) to issue up to \$14,000,000 in multi-family housing revenue bonds for Many Mansions or Affiliate (Shadow Hills Apartments), City of Thousand Oaks, County of Ventura.

The Board, by unanimous vote, without abstentions, adopted an initial resolution (resolution 15-117) to issue up to \$16,000,000 in multi-family housing revenue bonds for Barker Management or Affiliate (Watts Athens Apartments), City of Los Angeles, County of Los Angeles.

The Board, by unanimous vote, without abstentions, adopted an initial resolution (resolution 15-119) to issue up to \$50,000,000 in multi-family housing revenue bonds for Housing Authority of Santa Clara or Affiliate (Park Avenue Apartments), City of San Jose, County of Santa Clara.

The Board, by unanimous vote, without abstentions, adopted a final resolution (resolution 15-121) to issue up to \$21,000,000 in multi-family housing revenue bonds for Bellflower FM Community Partners, LP (Bellflower Friendship Manor Apartments), City of Bellflower, County of Los Angeles.

The Board, by unanimous vote, without abstentions, adopted a resolution (resolution 15-126), approving a form of tri-party agreement between the CMFA, Energy Efficient Equity and Inland Bond Capital, LLC, a form of first amended and restated program administration agreement with Energy Efficient Equity, and a form of master bond purchase agreement between the CMFA and Energy Efficient Equity, and approving related documents and actions for the CMFA PACE program.
