Executive Director, Edward Becker attended. Lee McCormick, John Stoecker, Ben Barker, Anthony Stubbs and Travis Cooper for Sierra Management Group L.L.C. attended as financial advisors to the Authority. Ron Lee of Jones Hall, APLC, attended as counsel to the Authority.

The minutes of the meeting(s) of the Board on June 3, 2016 were discussed and approved. Motion by Adams; Seconded by Moreno; Motion carries by unanimous vote, without abstentions.

The Executive Director reminded the Board that recommendations to the Board on agenda items were made on the respective staff reports provided and the Executive Director reiterated those recommendations.

The Board, by unanimous vote, without abstentions, adopted an initial resolution (resolution 16-101) to issue up to \$50,000,000 in multi-family housing revenue bonds for Standard Property Company or Affiliate (South Fulton Village Apartments), City of Santa Fe Springs, County of Los Angeles. Motion by Adams; Seconded by McCarthy; Motion carries.

The Board, by unanimous vote, without abstentions, adopted an initial resolution (resolution 16-102) to issue up to \$37,000,000 in multi-family housing revenue bonds for Beacon Pointe L.P. (Beacon Pointe Senior Homes/Beacon Place Supportive Homes for Veterans Apartments), City of Long Beach, County of Los Angeles. Motion by Moreno; Seconded by Adams; Motion carries.

The Board, by unanimous vote, without abstentions, adopted an initial (resolution 16-103) to issue up to \$40,000,000 in multi-family housing revenue bonds for Brookmore Apartment Corp. or Affiliate (Vista Tower), City of Los Angeles, County of Los Angeles.

The Board, by unanimous vote, without abstentions, adopted an initial (resolution 16-104) to issue up to \$30,000,000 in multi-family housing revenue bonds for Culver City Housing Partners, L.P., (Culver City Rotary Plaza Apartments), City of Culver City, County of Los Angeles.

The Board, by unanimous vote, without abstentions, adopted an initial (resolution 16-105) to issue up to \$14,000,000 in healthcare revenue bonds for Dignity Health (Citrus Heights Medical Office Building), City of Citrus Heights, County of Sacramento.

The Board, by unanimous vote, without abstentions, adopted an initial (resolution 16-106) to issue up to \$11,000,000 in multi-family housing revenue bonds for Eastgate Family Housing, LLC (Eastgate Apartments), City of San Marcos, County of San Diego.

The Board, by unanimous vote, without abstentions, adopted a final resolution (resolution 16-107) to issue up to \$8,500,000 in multifamily housing revenue bonds for Manzanita VOA Affordable Housing LP (Manzanita Place Tower Apartments), City of Roseville, County of Placer.

The Board, by unanimous vote, without abstentions, adopted a final resolution (resolution 16-108) to issue up to \$16,112,000 in multifamily housing revenue bonds for Eden Housing Inc. (Corona Ranch/ Washington Creek Apartments), City of Petaluma, County of Sonoma.

The Board, by unanimous vote, without abstentions, adopted a final resolution (resolution 16-109) to issue up to \$15,000,000 in revenue bonds for Goodwill Industries of Sacramento Valley & Northern Nevada, Inc., City of Sacramento, County of Sacramento and City of South Lake Tahoe, County of El Dorado.

The Board, by unanimous vote, without abstentions, adopted a final resolution (resolution 16-110) to issue up to \$25,000,000 in educational facility revenue bonds for Middlebury College, City of Monterey, County of Monterey.
