Executive Director, Edward Becker attended. Lee McCormick, Ben Barker, Anthony Stubbs and Travis Cooper for Sierra Management Group L.L.C. attended as financial advisors to the Authority. Steve Melikian of Jones Hall, APLC, attended as counsel to the Authority.

The minutes of the meeting(s) of the Board on June 24, 2016 were discussed and approved. Motion by Adams; Seconded by Watanabe; Motion carries by unanimous vote, without abstentions.

The Executive Director reminded the Board that recommendations to the Board on agenda items were made on the respective staff reports provided and the Executive Director reiterated those recommendations.

The Board, by unanimous vote, without abstentions, adopted an initial resolution (resolution 16-111) to issue up to \$50,000,000 in multi-family housing revenue bonds for Granger Housing, L.P. (Granger Apartments), City of National City, County of San Diego.

The Board, by unanimous vote, without abstentions, adopted an initial resolution (resolution 16-112) to issue up to \$9,500,000 in multi-family housing revenue bonds Providence House Oakland LP, (Providence House Oakland Apartments), City of Oakland, County of Alameda.

The Board, by unanimous vote, without abstentions, adopted an initial (resolution 16-113) to issue up to \$40,000,000 in multi-family housing revenue bonds Villa Pacifica II, L.P., (Villa Pacifica Apartments), City of Rancho Cucamonga, County of San Bernardino.

The Board, by unanimous vote, without abstentions, adopted an initial (resolution 16-114) to issue up to \$6,000,000 in multi-family housing revenue bonds for Mutual Housing or Affiliate (Owendale Mutual Housing Community), City of Davis, County of Sacramento.

The Board, by unanimous vote, without abstentions, adopted an initial (resolution 16-115) to issue up to \$41,000,000 in multi-family housing revenue bonds for Aliso Viejo 1776, L.P., (Liberty at Aliso Apartments), City of Aliso Viejo, County of Orange.

The Board, by unanimous vote, without abstentions, adopted a final resolution (resolution 16-116) to issue up to \$24,895,000 in multi-family housing revenue bonds for Crossroads, L.P. (Crossroads Apartments), City of Santa Rosa, County of Sonoma.

The Board, by unanimous vote, without abstentions, adopted a final resolution (resolution 16-117) to issue up to \$100,000,000 in multifamily housing revenue bonds for Pierce Park Apartments, LP (Pierce Park Apartments), City of Los Angeles, County of Los Angeles.

The Board, by unanimous vote, without abstentions, adopted a final resolution (resolution 16-118) to issue up to \$14,000,000 in multifamily housing revenue bonds for Antelope Valley Apartment Associates, LP (Antelope Valley Apartments), City of Lancaster, County of Los Angeles.

The Board, by unanimous vote, without abstentions, adopted a final resolution (resolution 16-119) to issue up to \$39,000,000 in multifamily housing revenue bonds for Sunnyvale Life, L.P. (Life's Garden Apartments), City of Sunnyvale, County of Santa Clara.
