- b. Authorized the execution and delivery of a second supplemental loan agreement for the Santa Margarita Catholic High School, City of Rancho Santa Margarita, County of Orange. (Resolution 16-143).
- c. Approve sponsorships to California City Management Foundation and California Affordable Housing Developers Association.

The Board, by unanimous vote, without abstentions, adopted a final (resolution 16-144) to issue up to \$15,933,000 in multi-family housing revenue bonds for Mackey Terrace EAH, L.P., (Mackey Terrace Apartments), City of Novato, County of Marin.

The Board, by unanimous vote, without abstentions, adopted a final resolution (resolution 16-145) to issue up to \$7,000,000 in multi-family housing revenue bonds for Walnut Place EAH, L.P., (Walnut Place Apartments), unincorporated Town of Point Reyes Station, County of Marin.
