In attendance at the Authority's meeting were Board Members Bob Adams, Paula Connors, Justin McCarthy, Faye Watanabe and Larry Westerlund comprising a quorum. Paula Connors served as chair. The meeting was called to order.

Executive Director, Edward Becker attended. Lee McCormick, John Stoecker, Ben Barker, Anthony Stubbs and Travis Cooper for Sierra Management Group L.L.C. attended as financial advisors to the Authority. Ron Lee of Jones Hall, APLC, attended as counsel to the Authority.

The minutes of the meeting(s) of the Board on November 18, 2016 were discussed and approved. Motion by Adams; Seconded by McCarthy; Motion carries by unanimous vote, without abstentions.

There was no public comment.

The Executive Director reminded the Board that recommendations to the Board on agenda items were made on the respective staff reports provided and the Executive Director reiterated those recommendations.

The following consent items were approved.

- b. Adopted a resolution (Resolution 16-200) approving the First Amendment to the 2012 Master Loan Agreement and the First Amendment to the 2013 Master Loan Agreement for the Buckley School, City of Los Angeles, County of Los Angeles.

The Board, by unanimous vote, without abstentions, adopted an initial resolution (resolution 16-205) to issue up to \$39,000,000 in multi-family housing revenue bonds for USA Properties Fund, Inc., (Ventura Apartments), City of San Buenaventura, County of Ventura.

The Board, by unanimous vote, without abstentions, adopted an initial resolution (resolution 16-206) to issue up to \$26,000,000 in multi-family housing revenue bonds for Posada de Colores, LP, (Posada De Colores Apartments), City of Oakland, County of Alameda.

The Board, by unanimous vote, without abstentions, adopted an initial resolution (resolution 16-209) to issue up to \$8,000,000 in multi-family housing revenue bonds for Eden Housing or Affiliate (Monterra Village Apartments), City of Gilroy, County of Santa Clara.

The Board, by unanimous vote, without abstentions, adopted an initial resolution (resolution 16-210) to issue up to \$40,000,000 in multi-family housing revenue bonds for Eden Housing or Affiliate (Redwoods & Wheeler Apartments), City of Gilroy, County of Santa Clara.

The Board, by unanimous vote, without abstentions, adopted a resolution (resolution 16-201) to issue up to \$200,000,000 in revenue bonds for Orange County, (Building 16), City of Santa Ana, County of Orange. Motion by McCarthy; Seconded by Watanabe; Motion carries.

The Board, by unanimous vote, without abstentions, adopted a final resolution (resolution 16-211) to issue up to \$14,750,000 in multi-family housing revenue bonds for Newark 618, L.P., (Newark Station Seniors Apartments), City of Newark, County of Alameda.

The Board, by unanimous vote, without abstentions, adopted a final resolution (resolution 16-212) to issue up to \$25,000,000 in revenue bonds for educational facilities for Linfield Christian School, City of Temecula, County of Riverside.

The Board, by unanimous vote, without abstentions, adopted a resolution (resolution 16-213) for the formation of a new joint powers authority (Antelope Valley-East Kern Water Agency Financing Authority) to finance projects for Antelope Valley-East Kern Water Agency, Los Angeles, Kern and Ventura Counties.

The Board, by unanimous vote, without abstentions, adopted a resolution (resolution 16-214) evidencing its approval of additional Members of the Authority.
