Executive Director, Edward Becker attended. Lee McCormick, John Stoecker, Ben Barker and Anthony Stubbs for Sierra Management Group L.L.C. attended as financial advisors to the Authority. Ron Lee and Chris Lynch of Jones Hall, APLC, attended as counsel to the Authority.

The minutes of the meeting(s) of the Board on December 9, 2016 were discussed and approved. Motion by Adams; Seconded by McCarthy; Motion carries by unanimous vote, without abstentions.

There was no public comment.

The Executive Director reminded the Board that recommendations to the Board on agenda items were made on the respective staff reports provided and the Executive Director reiterated those recommendations.

Discuss and Approve California Affordable Housing Development Association, California City Management Foundation, California Contract Cities Association, California Housing Consortium, California Council for Affordable Housing, California Society of Municipal Finance Officers, Council of Development Finance Agencies, GFOA, Healthcare Financial Management Association, Housing California, Kennedy Commission, Non-Profit Housing Association of Northern California, PACENation, SCANPH and San Diego Housing memberships.

The Board, by unanimous vote, without abstentions, adopted an initial resolution (resolution 17-001) to issue up to \$20,000,000 in multi-family housing revenue bonds for EE Cleveland Manor Preservation, L.P., (EE Cleveland Manor Apartments), City of Oakland, County of Alameda.

The Board, by unanimous vote, without abstentions, adopted an initial resolution (resolution 17-002) to issue up to \$15,000,000 in multi-family housing revenue bonds for Century Affordable Development, Inc., or Affiliate, (Beachwood Apartments), City of Long Beach, County of Los Angeles.
