Executive Director, Edward Becker attended. Lee McCormick, John Stoecker, Ben Barker and Anthony Stubbs for Sierra Management Group L.L.C. attended as financial advisors to the Authority. Steve Melikian and Josh Anzel of Jones Hall, APLC, attended as counsel to the Authority.

The minutes of the meeting(s) of the Board on January 13, 2017 were discussed and approved. Motion by Adams; Seconded by McCarthy; Motion carries by unanimous vote, without abstentions.

There was no public comment.

The Executive Director reminded the Board that recommendations to the Board on agenda items were made on the respective staff reports provided and the Executive Director reiterated those recommendations.

The following consent items were approved.

a. Approve Commercial PACE Bond Counsel Services Letter Agreement Between the CMFA, OnPACE Energy Solutions, LLC and Jones Hall, A Professional Law Corporation; Approve Conflict of Interest Waiver for Jones Hall.

The Board, by unanimous vote, without abstentions, adopted an initial resolution (resolution 17-010) to issue up to \$15,000,000 in multi-family housing revenue bonds for Domus Development, Inc., or Affiliate, (Blue Mountain Terrace Apartments), Town of Winters, County of Yolo.

Motion by Moreno; Seconded by Adams; Motion carries.

Proton by Protono, Seconded by Padams, Proton Carries.

The Board, by unanimous vote, without abstentions, adopted a final resolution (resolution 17-011) to issue up to \$5,779,953 in multi-family housing revenue bonds for Valentine Court, L.P., (Valentine Court Apartments), City of Santa Maria, County of Santa Barbara.

The Board, by unanimous vote, without abstentions, adopted a final resolution (resolution 17-012) to issue up to \$6,000,000 in revenue bonds for Southern California Development Corporation of VOA, INC., Cities of National City and San Diego, County of San Diego.

The Board, by unanimous vote, without abstentions, adopted a resolution (resolution 17-013) approving the formation of a new joint powers authority (Buena Vista Water Storage District) to finance projects for Buena Vista Water Storage District, unincorporated area of Buttonwillow, Kern County, California.

The Board, by unanimous vote, without abstentions, adopted a resolution (resolution 17-014) to delegate to the Executive Director authority to approve issuer fee adjustments (including for Buckley School, Sherman Oaks (Los Angeles), California; and to approve local joint powers authority transactions. Motion by McCarthy; Seconded by Adams; Motion carries.
