The Board, by unanimous vote, without abstentions, adopted an initial resolution (resolution 17-015) to issue up to \$40,000,000 in multi-family housing revenue bonds for Gilroy Lewis Street, L.P., (The Cannery Apartments), City of Gilroy, County of Santa Clara.

The Board, by unanimous vote, without abstentions, adopted an initial resolution (resolution 17-016) to issue up to \$20,000,000 in multi-family housing revenue bonds for Community Preservation Partners or Affiliate, (Desert Oasis Apartments), City of Indio, County of Riverside.
