Executive Director, Edward Becker attended. John Stoecker and Ben Barker for Sierra Management Group L.L.C. attended as financial advisors to the Authority. Ron Lee and Monica Baranovsky of Jones Hall, APLC, attended as counsel to the Authority.

The minutes of the meeting(s) of the Board on February 24, 2017 were discussed and approved. Motion by Adams; Seconded by Watanabe; Motion carries, with Westerlund abstaining.

There was no public comment.

The Board, by unanimous vote, with Moreno abstaining, adopted an initial resolution (resolution 17-025) to issue up to \$10,000,000 in multi-family housing revenue bonds for Santa Ana Arts Collective, L.P., (Santa Ana Arts Collective Apartments), City of Santa Ana, County of Orange.

The Board, by unanimous vote, without abstentions, adopted a final resolution (resolution 17-033) to issue up to \$155,000,000 in educational facility revenue bonds for University of La Verne, City of La Verne, County of Los Angeles.

The Board, by unanimous vote, without abstentions, adopted a final resolution (resolution 17-034) to issue up to \$90,000,000 in revenue bonds for Biola University, City of La Mirada, County of Los Angeles. Motion McCarthy; Seconded by Adams; Motion carries.

The Board, by unanimous vote, without abstentions, adopted a final resolution (resolution 17-035) to issue up to \$18,000,000 in revenue bonds for MBCS Properties, LLC, (Monterey Bay Charter School), City of Seaside, County of Monterey.

The Board, by unanimous vote, without abstentions, adopted a final resolution (resolution 17-037) to issue up to \$45,000,000 in educational facilities revenue bonds for Making Waves Foundation, Inc., City of Richmond, County of Contra Costa.
