The Executive Director reminded the Board that recommendations to the Board on agenda items were made on the respective staff reports provided and the Executive Director reiterated those recommendations.

Staff discussed an initial resolution (resolution 17-092) to issue up to \$11,00,000 in multi-family housing revenue bonds for DFA Cottage Village Associates, LP, (Cottage Village Senior Apartments), City of Manteca, County of San Joaquin.

Staff discussed a final resolution (resolution 17-093) to issue up to \$25,000,000 in multi-family housing revenue bonds for Posada de Colores LP, (Posada de Colores Apartments), City of Oakland, County of Alameda

Staff discussed a final resolution (resolution 17-094) to issue up to \$38,215,127 in multi-family housing revenue bonds for Renascent Place, L.P., (Renascent Place Apartments), City of San Jose, County of Santa Clara

Staff discussed a final resolution (resolution 17-097) to issue up to \$18,000,000 in revenue bonds for San Francisco Art Institute, City of San Francisco, County of San Francisco.

Staff discussed a final resolution (resolution 17-099) to issue up to \$2,500,000 in revenue bonds for OPTIONS Family of Services, Cities of Atascadero, Morro Bay, San Luis Obispo and Santa Maria, Counties of Santa Barbara and San Luis Obispo.

Motion by McCarthy; Seconded by Moreno; Motion carries by unanimous vote, without abstentions.
