Lee McCormick and Ben Barker for Sierra Management L.L.C. attended by phone. Ron Lee, of Jones Hall, APLC, attended as counsel to the Authority.

The Executive Director reminded the Board that recommendations to the Board on agenda items were made on the respective staff reports provided and the Executive Director reiterated those recommendations.

Staff discussed a final resolution (resolution 17-157) to issue up to \$55,000,000 in multi-family housing revenue bonds for Fruitvale Transit Village II-A, L.P, (Fruitvale Transit Village II-A Apartments), City of Oakland, County of Alameda.

Staff discussed a final resolution (resolution 17-158) to issue up to \$14,000,000 in multi-family housing revenue bonds for Piper Court Fairfax, L.P., (Piper Court Apartments), Town of Fairfax, County of Marin. Motion by Moreno; Seconded by Adams; Motion carries by unanimous vote, without abstentions.

Staff discussed a final resolution (resolution 17-159) to issue up to \$42,000,000 in multi-family housing revenue bonds for Mercy Housing California 66, L.P., (Colma Veterans Village Apartments), Town of Colma, County of San Mateo.
