Background:

MidPen Housing Corporation ("MidPen") is one of the nation's leading non-profit developers, owners and managers of high-quality affordable housing. MidPen has developed over 100 communities and 6,600 homes for low-income families, seniors and special needs individuals throughout Northern California over the last 40 years.

MidPen's developments are award winning and nationally recognized. MidPen has extensive experience in site acquisition and planning, entitlements, community outreach, design, and construction management. The organization has a solid track record in securing both public and private funding and proven expertise in positioning projects for long-term financial sustainability. In addition, MidPen provides comprehensive on-site services and programs to help residents advance. These services are delivered through the organization's staff and a network of over 300 service provider partners.

The CMFA has facilitated over 10 Mid-Peninsula Housing Coalition projects.

The Project:

The Shorebreeze Apartments is the new construction of a 62-unit affordable housing multifamily project. The project will be the second phase of an existing project built in 1980. Currently, the development consists of 120 affordable apartments. The new development will consist of the demolition of 12 existing townhomes and the creation of 62 new affordable apartments all located in one new building located at 460 N. Shoreline Boulevard, in the City of Mountain View, California. The units will be restricted to households earning between 50% and 60% or less of area median income (AMI). Amenities will include a courtyard, walking pathways, playground, community room, computer lab, bike lockers and laundry facilities. Services will be provided by MidPen Resident Services Corporation, a 501(c)3 affiliate of MidPen Housing Corporation that provides extensive on-site social services for MidPen residents. Services specific to Shorebreeze include a senior services coordinator to ensure the senior residents are strategically connected to community resources and a family services coordinator who will design and oversee an after-school program, and supportive services on an as needed basis. This financing will create 61 units of new affordable housing for the City of Mountain View for 55 years.

The City of Mountain View is a member of the CMFA and is scheduled to hold a TEFRA hearing on February 13, 2018. Upon closing, the City is expected to receive approximately \$13,295 as part of the CMFA's sharing of Issuance Fees.

Background:

Leaders & Scholars Two, LLC (the "Borrower") is a California limited liability company, whose sole member is Leaders & Scholars Inc., incorporated for the sole purpose of furthering the purposes of River Charter Schools (the "Corporation") is a California nonprofit public benefit corporation which was incorporated on April 11, 2006, formerly known as Friends of Clarksburg Schools. The Borrower's primary purpose is to own and improve the land located at the commonly known addresses of 899 Bryte Avenue, West Sacramento, California, and 36230 North School Street, Clarksburg, California, and lease each parcel to the Corporation.

The Corporation is an organization described under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (the "Code"). The Corporation operates Delta Elementary Charter School in Clarksburg, California ("DECS") and Lighthouse Charter School in the West Sacramento, California (the "Lighthouse" and, collectively with DECS, the "Schools"). The Schools operate pursuant to their respective charters authorized and approved by (i) the River Delta Unified School District ("RDUSD"), in the case of DECS, and (ii) Washington Unified School District ("WUSD").

River Charter Schools (the "School") established its first School, Delta Elementary Charter School ("DECS") in the small rural community of Clarksburg, California. The School believes that it is important to provide students with a strong commitment to academics, music, art, project based learning, learning garden, accelerated reader and technology. When the RDUSD announced

its plans to close Clarksburg Elementary School at the end of the 2005-2006 school year, a group of interested citizens initiated a course of action that led to the creation of DECS. After a year of deliberation, planning, and hard work, the School opened DECS on August 22, 2007, with an enrollment of 95 students and five teachers. By 2016, DECS had over 400 students. At DECS, the School serves students in grades TK-6, the majority of whom reside in the West Sacramento area.

The School subsequently opened Lighthouse in 2015. The School established this additional school at the request of parents in West Sacramento. These parents approached the School to replicate the DECS "model" in their area for their children.

The goal of the School is to provide in each school a multiethnic, student-centered learning environment that focuses on student achievement on an individual basis. The School's educational program is based on Common Core State Standards within an educational experience that includes technology, fine arts, athletics, and project based learning to support the intellectual, social, physical, and emotional development of the student.

The Project:

The proceeds of the Bonds will be used for a plan of finance consisting of financing and/or refinancing the following: (1) of the acquisition, construction, renovation and/or equipping of educational facilities located at 36230 N. School St., Clarksburg, California 95612 and at 841 Bryte Avenue, West Sacramento, California, each located within the geographical boundaries of the County; (2) capitalized interest, if necessary, with respect to the Bonds; (3) a reserve fund, if necessary, with respect to the Bonds; (4) refinancing existing debt secured by the facility at 36230 N. School St., Clarksburg, California 95612; (5) working capital, if necessary, with respect to the Bonds and (6) certain expenses incurred in connection with the issuance of the Bonds, including any applicable credit enhancement costs for the Bonds.

The City of West Sacramento and the County of Yolo:

The City of West Sacramento is a member of the CMFA and is scheduled to hold a TEFRA hearing on January 17, 2018. The County of Yolo is a member of the CMFA and is being asked to approve the financing. Upon closing, the City and County are expected to share approximately \$8,000 as part of the CMFA's sharing of Issuance Fees.

Background:

Barker Management, Inc. ("BMI") was formed in 1972 with the concept of providing quality property management services to the affordable housing market.

BMI began managing federally assisted housing, expanding over the years, to include conventional housing and commercial developments; however, its specialty continues to be the management of affordable housing. There are more programs than ever for affordable housing to utilize for subsidy, and Barker Management Incorporated has stayed abreast of the constant changes. Presently BMI manages properties that include a variety of subsidies from various agencies of programs including United States Department of Housing and Urban Development (HUD), Community, Federal and State Low Income Housing Tax Credits, State Bond Issuers, Federal Home Loan Bank's Affordable Housing program and other state and local funding sources.

Barker Management has developed into a full-service firm providing a multitude of services to its clients. Barker Construction and Development Company, a division of BMI, is fully bondable and specializes in major rehabilitation of multifamily developments. Another affiliate of BMI, Valued Housing, focuses on the acquisition, development and presentation of affordable housing developments. As a property management firm, BMI handles not only the daily management of a development, but also provides a variety of services. These services include accounting services, budget analysis, maintenance scheduling, monthly account reports, and BMI actively embraces technology to meet the unique and complex needs of our clients. This allows BMI to manage a development based on its specific needs as opposed to trying to make the development fit a standard management template.

The Baltimore and Leland Hotel Apartments project is an acquisition rehabilitation of a 200-unit and a 60-unit market rate hotel that will be converted to 100% affordable units. The scope of renovations will include updates to kitchens and bathrooms, new appliances, window coverings, and other upgrades throughout. Amenities include a community room, laundry room, secured entry with key card access and intercom, and on-site manager. There will also be 12,000 square feet of ground floor retail space. The project is located at 501 – 513 S. Los Angeles Street and 116 – 122 E. 5th Street, Los Angeles, California. This financing will provide 259 units of affordable housing in the City of Los Angeles for the next 55 years.
