Staff discussed an initial resolution (resolution 18-024) to issue up to \$44,000,000 in multi-family housing revenue bonds for Judson Terrace Senior Housing, L.P., (Judson Terrace Homes Apartments), City of San Luis Obispo, County of San Luis Obispo.
