Lee McCormick, Anthony Stubbs, Travis Cooper and Katrina Dair for Sierra Management Group L.L.C. attended by telephone. Ron Lee, of Jones Hall, APLC, attended as counsel to the Authority.

Staff discussed an initial resolution (resolution 18-069) to issue up to \$120,000,000 in multifamily housing revenue bonds for AMCAL Antioch Fund LP, (Antioch Housing), City of Antioch, County of Contra Costa. Motion by Watanabe; Seconded by Alexander; Motion carries by unanimous vote, without abstentions.

Staff discussed an initial resolution (resolution 18-070) to issue up to \$58,000,000 in multifamily revenue bonds for MP Bradford Associates, L.P., (Arroyo Green Apartments), City of Redwood City, County of San Mateo. Motion by Moreno; Seconded by Alexander; Motion carries by unanimous vote, without abstentions.

Staff discussed an initial resolution (resolution 18-072) to issue up to \$50,000,000 in tax-exempt revenue bonds for Aviation Facilities Company, Inc., (San Diego International Airport Cargo Project), City of San Diego, County of San Diego.

Motion by Watanabe; Seconded by Moreno; Motion carries by unanimous vote, without abstentions.

Staff discussed a final resolution (resolution 18-073) to issue up to \$5,500,000 in multifamily housing revenue bonds for Live Oak Pacific Associates II, L.P., (Kristen Court Apartments II), City of Live Oak, County of Sutter. Motion by Moreno; Seconded by Alexander; Motion carries by unanimous vote, without abstentions.

Staff discussed a final resolution (resolution 18-074) to issue up to \$100,000,000 in revenue bonds for California Lutheran University, City of Thousand Oaks, County of Ventura.
