Executive Director, Edward Becker attended. Lee McCormick, Ben Barker, Anthony Stubbs and Travis Cooper for Sierra Management Group L.L.C. attended as financial advisors to the Authority. John Stoecker and Katrina Dair for Sierra Management Group L.L.C. attended by telephone. Ron Lee, of Jones Hall, APLC, attended as counsel to the Authority.

Staff discussed an initial resolution (resolution 18-083) to issue up to \$45,000,000 in multifamily revenue bonds for AMCAL Las Ventanas Fund, L.P., (Las Ventanas Apartments), City of Long Beach, County of Los Angeles.

Staff discussed an initial resolution (resolution 18-084) to issue up to \$20,000,000 in multi-family housing revenue bonds for Self-Help Enterprises or an affiliate thereof, (Stonegate Village Apartments), City of Patterson, County of Stanislaus.
