Anthony Stubbs, Travis Cooper and Katrina Dair for Sierra Management Group L.L.C. attended by telephone. Monica Baranovsky, of Jones Hall, APLC, attended as counsel to the Authority. Steve Melikian, of Jones Hall, attended by telephone as counsel to the Authority.
