 a. Approve a resolution authorizing amendments to the Authority's revenue bond (Southeastern California Conference of Seventh-Day Adventists) Series 2013, Cities of Loma Linda and Escondido and Counties of San Bernardino and San Diego, and other matters. (Resolution 19-017)

Staff discussed an initial resolution (resolution 19-018) to issue up to \$75,000,000 in multifamily revenue bonds for Park Western Housing, L.P., (Park Western Estates Apartments), City of Los Angeles, County of Los Angeles.

Motion by Moreno; Seconded by De Foor; Motion carries by unanimous vote, without abstentions.

Staff discussed an initial resolution (resolution 19-019) to issue up to \$35,000,000 in multifamily revenue bonds for 950 El Camino Real, LP, (950 El Camino Real Apartments), City of Mountain View, County of Santa Clara. Motion by De Foor; Seconded by Watanabe; Motion carries by unanimous vote, without abstentions.

Staff discussed an initial resolution (resolution 19-020) to issue up to \$8,000,000 in multifamily revenue bonds for Veterans Resource Center of America or an Affiliate thereof, (Shasta Lake Veterans Village Apartments), City of Shasta Lake, County of Shasta.
