  - b. Approve Silver Sponsorship for the 2019 California Bond Buyer Conference.

Staff discussed an initial resolution (resolution 19-042) to issue up to \$20,000,000 in multifamily revenue bonds for LINC Housing Corporation or an affiliate thereof (PCH & Magnolia Apartments), City of Long Beach, County of Los Angeles.

Staff discussed an initial resolution (resolution 19-043) to issue up to \$18,000,000 in multifamily revenue bonds for C&C Development Co., LLC or an affiliate thereof (The Grove Apartments), City of San Juan Capistrano, County of Orange.
