# Regular Meeting of the Board of the California Municipal Finance Authority (the "Authority")

In attendance at the Authority's meeting were Board Members Andrew Alexander, as a voting member, Paula Connors, Justin McCarthy and Faye Watanabe, comprising a quorum. Paula Connors served as chair. The meeting was called to order.

Executive Director, Edward Becker attended. John Stoecker, Ben Barker and Travis Cooper, of Sierra Management Group L.L.C., attended as financial advisors to the Authority. Anthony Stubbs and Katrina Dair, of Sierra Management attended by telephone. Ron Lee, of Jones Hall, APLC, attended as counsel to the Authority.

The minutes of the meeting(s) of the Board on June 28, 2019 were discussed and approved. Motion by Watanabe; Seconded by McCarthy; Motion carries by unanimous vote, without abstentions.

There was no public comment.

The Executive Director reminded the Board that recommendations to the Board on agenda items were made on the respective staff reports provided and the Executive Director reiterated those recommendations.

Staff discussed an initial resolution (resolution 19-089) to issue up to \$42,000,000 in multifamily housing revenue bonds for BRDIGE Berkeley Way LP, (Bridge Berkeley Way Affordable), City of Berkeley, County of Alameda.

Staff discussed an initial resolution (resolution 19-090) to issue up to \$19,000,000 in multifamily housing revenue bonds for BFHP Hope Center LP, (BFHP Hope Center Permanent Supportive Housing), City of Berkeley, County of Alameda.

Staff discussed a final resolution (resolution 19-093) to issue up to \$7,000,000 in revenue anticipation notes River Springs Charter School, Inc., City of Temecula, County of Riverside.

The Board discussed and approved selection process for financial advisory and administrative services. Motion by Watanabe; Seconded by McCarthy; Motion carries by unanimous vote, without abstentions.

The Board authorized the Executive Director, in consultation with CMFA's regular issuer's counsel, to engage litigation counsel, waive actual and potential conflicts, and negotiate and agree to indemnity, defense, settlement, waiver, release and confidentiality agreements, and all other related matters in furtherance of the protection of the interests of the CMFA, in claims, controversies or disputes with an amount in controversy more than \$10,000. The Executive Director and issuer's counsel are to consult with

two board members prior to taking any such action. Any actions taken pursuant to this authority are to be reported to the Board of Directors at the next meeting.
