Executive Director, Edward Becker attended. Lee McCormick, Ben Barker and Travis Cooper, of Sierra Management Group L.L.C., attended as financial advisors to the Authority. John Stoecker and Katrina Dair, of Sierra Management attended by telephone. Ron Lee, of Jones Hall, APLC, attended as counsel to the Authority.

The minutes of the meeting(s) of the Board on August 30, 2019 were discussed and approved. Motion by Watanabe; Seconded by Adams; Motion carries by unanimous vote, without abstentions.

There was no public comment.

The Executive Director reminded the Board that recommendations to the Board on agenda items were made on the respective staff reports provided and the Executive Director reiterated those recommendations.

Staff discussed an initial resolution (resolution 19-108) to issue up to \$21,000,000 in multifamily housing revenue bonds for Simi Vintage Sycamore 650, L.P., (Vintage at Sycamore Apartments), City of Simi Valley, County of Ventura.

Staff discussed an initial resolution (resolution 19-110) to issue up to \$8,000,000 in multifamily housing revenue bonds for El Centro Pacific Associates, a California Limited Partnership, (El Dorado Family Apartments), City of El Centro, County of Imperial.
