In attendance virtually for the Authority's meeting were Board Members Andrew Alexander, as a voting member, Bob Adams, Paula Connors, Joya De Foor, as a voting member, and Justin McCarthy, comprising a quorum. Paula Connors served as chair. The meeting was called to order.

Executive Director, Edward Becker attended virtually. John Stoecker, Lee McCormick, Ben Barker, Anthony Stubbs and Travis Cooper, of Sierra Management Group, LLC attended virtually as financial advisors to the Authority. Katrina Dair and Alexis Tudor of Sierra Management Group, LLC attended virtually. Ron Lee and Brian Haroldson, of Jones Hall, APLC, attended virtually as counsel to the Authority.

The minutes of the meeting(s) of the Board on September 11, 2020 were discussed and approved. Motion by Alexander; Seconded by De Foor; Motion carries unanimously by a roll call vote, without abstentions.

There was no public comment.

The Executive Director reminded the Board that recommendations to the Board on agenda items were made on the respective staff reports provided and the Executive Director reiterated those recommendations.

The Board approved an initial resolution (resolution 20-189) to issue up to \$6,000,000 in multifamily housing revenue bonds for Corallina CIC, LP, (Corallina at Pacific Highlands Ranch Apartments), City of San Diego, County of San Diego.

Motion by Alexander; Seconded by De Foor; Motion carries unanimously by a roll call vote, without abstentions.

The Board approved an initial resolution (resolution 20-190) to issue up to \$55,000,000 in multifamily housing revenue bonds for Bell St. Gardens, L.P., (Bell Street Gardens Apartments), City of Fremont, County of Alameda.

Motion by McCarthy; Seconded by Alexander; Motion carries unanimously by a roll call vote, without abstentions.

The Board approved an initial resolution (resolution 20-191) to issue up to \$100,000,000 in multifamily housing revenue bonds for BRIDGE Housing Corporation or an affiliate thereof, (Fruitvale Transit Village Phase IIB Apartments), City of Oakland, County of Alameda.

Motion by Alexander; Seconded by De Foor; Motion carries unanimously by a roll call vote, without abstentions.

The Board approved an initial resolution (resolution 20-192) to issue up to \$20,000,000 in multifamily housing revenue bonds for Eden Housing Inc. or an affiliate thereof, (Villa Ciolino Apartments), City of Morgan Hill, County of Santa Clara.

Motion by Adams; Seconded by Alexander; Motion carries unanimously by a roll call vote, without abstentions.

The Board approved a final resolution (resolution 20-193) to issue up to \$40,000,000 in multifamily housing revenue bonds for Wakeland Trinity Place LP, (Mission Heritage Plaza Apartments), City of Riverside, County of Riverside.

Motion by McCarthy; Seconded by Alexander; Motion carries unanimously carries by a roll call vote, without abstentions.

The Board approved a final resolution (resolution 20-194) to issue up to \$23,000,000 in multifamily housing revenue bonds for Sequoia Commons II, L.P., a California limited partnership (Sequoia Commons II Apartments), Community of Goshen, County of Tulare.

Motion by Alexander; Seconded by Adams; Motion carries unanimously by a roll call vote, without abstentions.

The Board approved a final resolution (resolution 20-195) to issue up to \$5,600,000 in multifamily housing revenue bonds for Fairbanks Terrace II CIC, LP, a California limited partnership, (Fairbanks Terrace II Apartments), City of San Diego, County of San Diego.

Motion by Adams; Seconded by Alexander; Motion carries unanimously by a roll call vote, without abstentions.

The Board approved a final resolution (resolution 20-196) to issue up to \$32,500,000 in multifamily housing revenue notes for AMCAL Washington Fund, L.P., a California limited partnership, (La Prensa Libre Apartments), City of Los Angeles, County of Los Angeles.

Motion by De Foor; Seconded by McCarthy; Motion carries unanimously by a roll call vote, without abstentions.

The Board approved a final resolution (resolution 20-197) to issue up to \$40,000,000 in multifamily housing revenue notes for AMCAL Las Terrazas Fund, LP, a California limited partnership, (Las Terrazas Apartments), City of Colton, County of San Bernardino.

Motion Alexander; Seconded by McCarthy; Motion carries unanimously by a roll call vote, without abstentions.

The Board approved a final resolution (resolution 20-198) to issue up to \$20,000,000 in multifamily housing revenue notes for Mutual Housing 5th Street, LP, a California limited partnership, (Mutual Housing at 5th Street Apartments), City of Davis, County of Yolo.

Motion by Alexander; Seconded by Adams; Motion carries unanimously by a roll call vote, without abstentions.

The Board approved a final resolution (resolution 20-199) to issue up to \$25,000,000 in multifamily revenue notes for Wilton ECR L.P., a California limited partnership, (Wilton Court Apartments), City of Palo Alto, County of Santa Clara.

Motion by De Foor; Seconded by McCarthy; Motion carries unanimously by a roll call vote, without abstentions.

The Board approved a final resolution (resolution 20-200) to issue up to \$110,000,000 in tax-exempt loans for Scripps College, City of Claremont, County of Los Angeles.

The Board approved a final resolution (resolution 20-201) to issue up to \$61,000,000 in revenue bonds for Caritas Acquisitions I, LLC, (Caritas Mobile Homes) Cities of Lancaster, Napa, Vacaville and Newcastle, Counties of Los Angeles, Napa, Solano and Placer.

Motion by Adams; Seconded by Alexander; Motion carries unanimously by a roll call vote, without abstentions.

The Board approved a final resolution (resolution 20-202) to issue up to \$21,500,000 in multifamily revenue refunding notes for Coliseum Transit Village One, LP, (Coliseum Connections Apartments), City of Oakland, County of Alameda.

Motion by De Foor; Seconded by McCarthy; Motion carries unanimously by a roll call vote, without abstentions.

The meeting of the Board was temporarily adjourned for a break between 10:39 a.m. and 11:00 a.m. and reconvened at 11:00 a.m.

Motion by De Foor; Seconded by Adams; Motion carries unanimously by a roll call vote, without abstentions.

Staff discussed a resolution (resolution 20-205) calling a special election in and for California Municipal Finance Authority Community Facilities District No. 2020-7 (City of Elk Grove – Mendes). Motion by Adams; Seconded by Alexander; Motion carries unanimously by a roll call vote, without abstentions.

Secretary Bob Adams announced the results of the election.

First reading of Ordinance (Ordinance 20-06) was waived, levying special taxes within California Municipal Finance Authority Community Facilities District No. 2020-7 (City of Elk Grove – Mendes).
