The Board approved an initial resolution (resolution 20-242) to issue up to \$35,000,000 in multifamily housing revenue bonds for Vallejo PSH, L.P., (Sacramento Street Apartments), City of Vallejo, County of Solano.

The Board approved a final resolution (resolution 20-247) to issue up to \$15,000,000 in tax exempt revenue bonds for STREAM Charter School, City of Oroville, County of Butte.

The Board approved a final resolution (resolution 20-248) to issue up to \$55,000,000 in revenue bonds for Community Health Centers of the Central Coast, Cities of Arroyo Grande, Cambria, Nipomo, Paso Robles and Santa Maria, Counties of Santa Barbara and San Luis Obispo.

The Board approved a final resolution (resolution 20-249) to issue up to \$13,000,000 in revenue bonds for PCA Facilities Shasta View LLC, or entities related thereto, (Phoenix Charter Academy), City of Redding, County of Shasta.
