The Board approved a final resolution (resolution 21-117) to issue up to \$91,000,000 in multifamily housing revenue loans for 3511 East 12th Street LP, a California limited partnership, (Casa Suenos FKA Fruitvale Transit Station Apartments), City of Oakland, County of Alameda.

The Board approved a final resolution (resolution 21-118) to issue up to \$100,000,000 in multifamily housing revenue loans for MP Midway Associates I, L.P., a California limited partnership, (Midway Village Phase I Apartments), City of Daly City, County of San Mateo.

The Board approved a final resolution (resolution 21-119) to issue up to \$8,000,000 in revenue bonds for Baywood Court, a California nonprofit, public benefit corporation, (Baywood Court), census designated place of Castro Valley in an unincorporated area of the County of Alameda.

The Board approved a final resolution (resolution 21-120) to issue up to \$319,000,000 in revenue bonds for CHF-Davis II L.L.C., a limited liability company, (University of California, Davis – Orchard Park), Unincorporated Area of County of Yolo.

The Board approved a resolution (resolution 21-122) to establish CMFA Community Facilities District No. 2021-8, Pacific Communities, (City of Lancaster – Pacific Palacio); and to levy a special tax to finance certain public facilities therein.

The Board approved a resolution (resolution 21-125) authorizing the issuance and sale of special tax revenue bonds (BOLD Series 2021A) in an amount not to exceed \$25,000,000, and related issuance and purchase of special tax bonds issued for and on behalf of Improvement Area No. 1 of CFD No. 2019-2 (Town of Truckee – Coldstream) in amount not to exceed \$2,590,000, Improvement Area No. 2 of CFD No. 2020-3 (City of Elk Grove – Madeira Meadows) in amount not to exceed \$3,780,000, CFD No. 2020-8 (County of Placer – Eureka Grove) in amount not to exceed \$3,165,000, CFD No. 2020-10 (City of Lincoln – Twelve Bridges) in amount not to exceed \$10,255,000, CFD No. 2021-2 (City of Rancho Cordova – Douglas 98) in amount not to exceed \$3,220,000, and CFD No. 2021-5 (City of Lincoln – Greyson) in amount not to exceed \$1,990,000, and approving related agreements and actions.
